- 1) To supplement technical supports and inputs towards planning & design and guidance for the important project being implemented by the Department.
- 2) The State Technical Agency (STA) will examine the DPR's for different projects under the Department for their adherence to the required format and structure as well as meeting other requirement as laid down for such projects.
- 3) To design different components for the water supply system, if needed.
- 4) To conduct different field investigations required for planning & design of the system and preparation of BOQ, if situation demands.
- 5) To advice the Department to engage agency / agencies for field investigations, if deem necessary.
- 6) To held and advice all such matter which may require by the Department to promote, adopt, generate, modify technologies for sustainable service delivery.
- 7) All of their activities will be carried out with specific direction from the Department communicated through the Covenor -cum-Coordinator of the Group.
- 8) The Chairman State Technical Agency (STA) will have the liberty to induct co-opted members as and when necessary.

Honorarium at normally admissible / mutually agreed rate will be paid on daily / job basis. For field visit, if required for the team, necessary vehicle, fooding, lodging etc., will be arranged by the PHE Department / Division. The formation of STA may be modified, if required.




