He should report and join in his duty within 7 (seven) days from the date of issue of this order. Subject to failing to join the office within 7 (seven) days and adverse police verification report this order will automatically be treated as cancelled.

The government servant joining their service on or after 1st February/2005 shall not be governed by the existing Assam service (Pension) Rules 1969 and other orders issued there under from time to time. So far as there pension and other retirement benefits are concerned, they will be governed by the New pension rules of the Government of Assam.

The appointee has to executed and under take to the effect that he abide by the New Define contribution pension scheme vide Govt. Circular No. BW-3/2003/Pt-II/1 Dated 25-01-2005.
