Dispur the 13<sup>th</sup> September'2022 & Finance SIU Department vide No. FSI.354/2022 dtd. 12/09/2022 recommended by SPL Secretary to the Govt. of Assam, Public Health Engineering Department, Dispur dtd. 13<sup>th</sup> Sept'2022 Sri Jintu Rajbongshi is hereby appointed on compassionate ground in the post of Khalasi in the Office of the Executive Engineer (PHE), Guwahati Division No-I, Bamunimaidam, Guwahati-21 against the Govt. sanctioned vacancy No. HLB-320/77/332 Dated 23-03-1984 in the Scale of Pay Band Rs. 12,000.00-52,000.00/P.M. Plus Grade Pay of Rs. 3900.00/P.M. (PB-I) plus all other allowances as admissible under rule.

The appointment is purely temporary and may be terminated at any times without notice and assign any reasons thereof. Other term & conditions regarding N.P.S. Pension, benefit etc. will be entertained as per prevailing latest Govt. Rules and procedures along with he will maintain properly the other family members who were dependent on the Govt. servant in question. In case it is provide subsequently (at any time) that the family members are being neglected or are not being maintain properly by his appointment may be terminated forthwith. This condition is to be incorporated as on of the additional condition in the offer of appointment.

However, as per SPL Secretary to the Govt. of Assam, Public Health Engineering Department vide letter mentioned above the incumbent will be allowed to join the service only after verifying credential as in original to match the service rule of the cadre.


