In pursuance of the approval of the BTC, Kokrajhar vide No. BTC/PHE-15/2004-A/341, Dt. 12-09-2022 and communicated by the Addl. Chief Engineer (PHE) cum Director, PHED, BTR, Kokrajhar vide his letter No. DIR/PHED/KOR/Estt-41(Pt-IV)/2022-23/2493, dt 12/09/2022, Sri Rafwt Khungur Brahma, son of Late Dhananjay Kr. Brahma, Ex. UDA, Vill- Kadamtola, P.O.- Dotma, P.S.- Dotma, Dist.- Kokrajhar, BTAD, Assam, PIN Code 783347 is hereby appointed as Jr. Asstt. on compassionate ground (LDA) in the scale of pay of Rs. 14,000.00 to 60,500.00 with grade pay 6200.00 p.m. (Pay Band-II) and other allowances as admissible from time to time against the vacant post created and sanctioned by the Govt. of Assam vide No. HLB-622/84/35, dt. 08-02-1985 and permanent retention No. PHED-230/2010/61 dt. 29-11-2010 of Kokrajhar Division No-I and posted in the office of the Asstt. Executive Engineer, Dotma (PHE) Sub-Division, Dotma. The appointment is purely temporary and may be terminated without any notice and without assigning any reason thereof.

He should report and join in his duty within 15 (fifteen) days along with Medical Certificate of the competent authority from the date of issue of this order. Non joining to the post within 15 (fifteen) days and adverse Police Verification Report this order will automatically be treated as cancelled.

The Government servant joining their service on or after 1st February, 2005 shall not be governed by the existing Assam Service (Pension) Rules, 1969 and other orders issued there under from time to time. So far as their pension and other retirement benefits are concerned, they will be governed by the New Pension Rules of the Government of Assam.

The appointee has to execute an undertaking to the effect that he will abide by the New Define Contribution Pension Scheme vide Govt. Circular No. BW-3/2003/Pt-II/1, dt. 25-01-2005.

Further the appointee has to execute an undertaking also regarding proper maintaining of the other family members who are dependent on the Govt. Servant in pursuance of Govt. letter No.- PHED-83/2015/Pt/382 dt. 13-09-2022.
